THE ORIGIN OF THE HUMAN FAMILY

The book of Genesis teaches that the HUMAN FAMILY is the third oldest institution of the four Divinely Established Institutions (DI) designed by God in the world.

Today, the world's view of the human family differs from that of the Bible. Here are five examples of the world's view of the family as a human institution.

- Evolution views the human family along with plants and animals (kingdom, phula, class, order, genea, and species).
- Sociology views the human family as a kinship group providing for the welfare of children and certain other kinship needs.
- **Anthropology** views the human family as a social grouping united by bonds of kinship with a sense of belonging.
- **Psychology** views the human family as a kinship grouping that develop personality and interaction of personal relationships.
- Webster English Dictionary defines the human family as a basic unit in society having as it nucleus 2 or more parents living together and cooperating in the care and rearing of their own or adopted children.

This lesson will study SIX aspects of the biblical Origin of the Human Family in order to understand its purpose and function in the plan of God

1. The fourth chapter of Genesis introduces the human family as a divine institution with laws of divine establishment to give it structure for communal society (Gen.4:1-2).

We will mention seven divine laws of establishment that give structure to the family for communal society.

- One divine law is that parents are responsible for the godly training of children (Prov.1:8; 6:20; 22:6).
- Second divine law is that parents are not to crush the spirit of their children (Eph.6:4; Col.3:21).
- Third divine law is that children are to obey their parents while living at home (Eph.6:1; Col.3:20).
- Fourth divine law is that children are to honor their parents after leaving the home (Eph.6:2-3; Deut.5:16: Prov.31:28-30).
- Fifth divine law is that authority entrusted with the care of children must not victimize them (Matt. 18:3-6).
- Sixth divine law is that grown children are responsible to care for their aged grandparents and parents (1 Tim.5:4-8).
- Seventh divine law is that grown children are not to neglect or abuse their responsibility or to abuse their aged grandparents or parents (Matt.15:1-9).

The home is the first place to live godly and not the last place. The story of Noah teaches that the family that puts God first will be the family God puts first (Gen.6-8) "By faith Noah, when warned about things not yet seen, in holy fear built an ark to save his family. By his faith he condemned the world and became heir of the righteousness that comes by faith." (Heb.11:7).

3.	DI#3 (human family) was given the first commandment of God with a divine promise (Deut.5:16 Eph.6:3).

	 and relating intimately to others. The family is the child's first phase of personality development such as self-esteem and worth. The family is the child's first stage of soul development such as self-consciousness and conscience and mentality and emotions. 		
	 The family is the child's first place for experiencing OSN lust patterns as well as developing OMCI core patterns of thinking.

	 The Christian family should be the child's first place of encouraging spiritual growth developmen and life of faith in God's word.
